Electronic bid must be submitted to the koshi hospital biratnagar through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 18-June-2021.

- 5. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 14:00 hour (Local time) on 18-June-2021 at the office of Koshi Hospital, Biratnagar.
- 6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 7. Bidders can also submit their bid partially or Itemwise. Lowest Price coding with complete documentation will be consider for evaluation.
- 8. In the case of discrepancies or error in bid documents, bid notice or any other document, the purchaser reserve the right to amend and correct at any time.

9. If the budget for this Procurment cannot be ensured, the hospital may suspend the procurement.
